

$$\frac{\$5,000 \text{ (FMV of portion sold)}}{\$10,000 \text{ (FMV of aggregated property)}} \times \$12,000 \text{ (adjusted basis for loss)} = \$6,000 \text{ (adjusted basis of portion sold)}$$
